

Delta Chi Association - Purpose

Delta Chi Association - Purpose



Responsible for long term stewardship of the Delta Chi Chapter of DKE and our lodge at 13 South Avenue. This includes:

- Supporting and mentoring actives as they manage the day to day and year to year activities of the chapter.
- Ensure that our chapter lodge remains a viable living space for Dekes now and into the future.
- Engage with chapter alumni to ensure continued involvement and financial support is in place to keep the DX chapter strong.
- Building enduring relationships with Cornell and DKE International partners.



Delta Kappa Epsilon – Year in Review

2022-23 Academic Year in Review



The 2022-23 school year had it's share of successes:

- A highly successful Fall rush welcomed 6 new brothers, followed by a Spring rush of 14 additional brothers for a total of 20!
- The undergraduates achieved a combined house GPA of 3.47.
- Multiple philanthropy events were held in the Ithaca area.
- Fall fundraiser honoring Clifton Beckwith Brown's birthday raised enough money to upgrade the sound system, replace the refrigerators, and upgrade the flooring in the weight room
- Our Giving Day raised more than \$80,000; more than 100 donors.
- Successful Spring Retreat; mini-retreat for new members



Facility Improvements

Facility Improvements – 2022/23



House improvements completed in 2022-23:

- Rehabilitated stone and wood features on the western face
- Repaired the library chimney and main tower
- Replaced aging pipes providing water to 2nd floor bathrooms
- Planted barrier trees and rebuilt the courtyard flowerbed
- Connected gutters to underground ducts for better drainage
- Replaced several stained-glass windows in the chapter room

Facility Improvements – In Progress



Projects in some state of progress:

- Replacement of the current kitchen hood fan with a grease fan (To be completed summer 2023)
- Repair and resurfacing the house parking lot (To be completed summer 2023)
- Negotiating the provision of 3-phase electric power with NYSEG (Plan to be completed this Fall)

Facility Improvements – Up Next



Projects under consideration for the next year:

- Major focus to upgrade the electrical system
- Multi-year project with first step to get NYSEG to bring 3-phase power to the house
- More communications once the components and timeframes become clearer
- Project will include rehabilitation to the basement storage areas near kitchen to house new electrical distribution hub
- Continue small projects in coordination with undergrads



Chapter Finances

DKE Financials - Background



DKE gets dollars through a number of channels:

- Undergraduates put a percentage of their room fees into Cornell's facility reserve fund to support house maintenance.
- Gifts to Cornell designated for the DKE Group Housing Fund, as well as payouts from our Cornell endowments, are directed to house improvements.
- The Delta Chi Association collects annual dues and other contributions. These dollars can be spent on alumni networking events, our website and newsletter, or facility improvements.

DKE Financials - Background

Other items of interest:



- The Robert Trent Jones Memorial Delta Kappa Epsilon Fraternity Scholarship has surpassed a \$1,000,000 market value! Over \$35,000 in scholarships went to 7 Dekes last year.
- Endowments from Jordan Lamb and Eugene Patterson have a combined market value of over \$400,000 and contribute about \$7,000 a year to the house accounts.
- If you're considering leaving money to DKE in your estate, or a beneficiary of your IRA, let us know and we can discuss how to set that up for the maximum benefit to DKE.
- The Delta Chi Association can now take contributions in stock. If you're sitting on an unrealized capital gain, send us the stock and avoid the capital gains taxes!

DKE Income for 2022-23 Academic Year:

- Dues and gifts to the Delta Chi Association: \$24,950
- Gifts to Cornell's DKE Housing Fund: \$101,835 (includes Giving Day)
- YTD proceeds from Lamb and Patterson endowments: \$6,928

DKE Financials - Expenses



Delta Chi Association Expenses:

- House improvement projects (west wall restoration, chimney)
- Targeted projects with alumni contributions (new refrigerator)
- Brotherhood rituals (initiation dinner, senior dinner)
- Brother/alumni event funding (Homecoming, Reunion)
- Scholarship Book Awards (supplement RTJ dollars)
- Conference Attendance (ADW Greek Summit; DKE Convention)
- Website, Delta Chi Deke, and other communications costs
- Additional liability insurance coverage

- We put significant money into the physical plant for completing projects or the scoping, assessment, or design of future projects. We will continue to have projects that overlap from one year to the next.

Giving Day 2023 Sets Deke Record for the Third Straight Year!


